#### 1. Chair's remarks

Chair M. Singh welcomed Council members and reminded Council members and guests to sign the attendance book and to note upcoming Council meetings.

She asked Council members to review the materials posted on the Council website regarding the proposed revisions to the Principles and Procedures Governing Non-Degree Activities and provide feedback.

#### 2. Minutes of the Meeting April 3, 2019

Professor J. Check, seconded by Professor N. Richardson that the minutes of the April 3, 2019 meeting of Council be approved. The motion carried.

#### 3. Business Arising from the Minutes

There was no business arising from the minutes.

#### 4. Dean's Remarks

Dean McDonald welcomed Council members and began by thanking all the faculty and staff members who are organizing year-end celebrations for students including award evenings and recognition events.

Dean McDonald extended his congratulations to Professor A. Muise on the receipt of her York Research Chair. This will make Professor Muise the first Tier II YRC in the faculty. He also offered congratulations to Professor E. Peisachovich was the recipient of the 2019 D2L Innovation Award in Teaching and Learning which recognizes educators who are redefining the learning experiences of students through innovative practices.

Dean McDonald congratulated those faculty members who submitted and were approved for AIF funding. There were a total of 5 proposals approved from the Faculty of Health.

Congratulations to Professors I. Epstein, E. Peisachovich, L. Appel, C. Da Silva, S. Skerritt and P. Safai.

Dean McDonald also commented that a recent donation was made to the Faculty of Health by former Science faculty member, Allan Carswell. It has been endowed in honour of his wife and will support Masters and PhD students studying in the area of dementia care.

#### 5. Report of the Executive and Planning Committee

On behalf of the Executive and Planning Committee, Professor M. Morrow noted that processes to fill vacancies on Standing Committees of Council were underway in Schools/Department. Members were encouraged to connect with their nominating committee for additional information.

The Executive and Planning Committee was established as summer authority for the Faculty of Health Council and will report back to Council in the Fall on any actions taken under that authority.

There was a call for nominations for the vacant position of Vice-Chair of Council from July 1, 2019 to June 30, 2021. Professor H. Jordan and Professor M. Singh were nominated for the role and an election followed. Professor M. Singh was elected to the role of Vice-Chair of Council.

There was a call for nominations for the vacant position of an "at-large" seat on the Petitions Committee from July 1, 2019 to June 30, 2021. It was noted that Professor H. Jenkin, Department of Psychology is a continuing 'at-large' member and the two 'at large' members shall not be from the same School/Department. Professor O. Stein was nominated for this role and was acclaimed to the position.

There was a call for nominations for the two vacant positions of Faculty of Health Senator. It was noted that Professor S. Grace and Professor M. Singh were nominated. Professor S. Rosenbaum was nominated from the floor and an election followed. Professor S. Grace and Professor S. Rosenbaum were elected as Faculty of Health Senators.

Professor M. Morrow provided background on the Global Health Program Executive Committee Report. She explained the current governance of the Global Health program and the consultation process. The report that was provided offered three possible options for the Global Health program: (1) status quo (2) align the program within an existing Faculty of Health unit and (3) the creation of a new school of Global Health.

Dean McDonald explained to Council members that the intent behind the original motion put forward in the Executive and Planning report had changed. He stated that rather than voting on the motion provided in the Executive and Planning Report, Faculty Council would be voting instead to consider the options available and to proceed with that process.

Professor M. Morrow motioned, seconded by Professor B. Pilkington, to approve in principle, the formal process leading to a proposal to establish a School of Global Health in the Faculty of Health.

# 6. Report of the Curriculum Committee

Professor S. Murtha provided a presentation on the proposed Neuroscience Degree. As the external reviewer's report was not available in time for Council, she provided an email from the reviewer that stated that he could not see any concerns to fully supporting the creation of the program.

On behalf of the Curriculum Committee, Professor S. Murtha motioned, seconded by Professor M. Fallah, that Council approve the establishment of a Bachelor of Science Specialized Honours program in Neuroscience, as set out in the Neuroscience Proposal, effective Fall/Winter 2020-2021. The motion carried.

On behalf of the Curriculum Committee, Professor S. Murtha motioned, seconded by Professor M. Fallah, that Council approve the new rubric Neuroscience (NRSC) effective Fall/Winter 2020-2021. The motion carried.

### 7. Report of the Petitions Committee

Professor L. Seto Nielsen provided the Petitions Committee report. The 2018-2019 report referred to the reduction in the number of petitions adjudicated as a result of the labour disruption compared to 2017-2018. The committee was also responsible for initiating several policies to support students and to bridge strike-related Senate policies in order to better manage post-strike issues. The full report is available on the Council website for members to review. She thanked the committee members and Petitions Coordinator for their hard work.

#### 8. Senator's Report

In lieu of an in-person report, the April Senate meeting report is posted to the Faculty Council website for members to review.

#### 9. Other Business

There was no other business.


